Cancellations: 50% of your rental rate will not be refunded

Damaged Equipment: Renter shall pay all repair costs associated with damaged equipment. McNulty Nielsen shall be the sole assessor of damage. Rental will continue until repairs are completed in cases of impact damage (cracked or broken LCD screens, scratched lenses etc) Damages will be charged to the credit card on file.

McNulty Nielsen, Inc is not responsible for any liabilities, claims, costs, or expenses arising from the use of our services or equipment. We offer and encourage the production company to inspect and test the equipment at our facility prior to working with us. When renting monitors, follow focus, matte boxes etc McNulty Nielsen cannot be responsible for incompatibility of equipment. We encourage you to test these items before you place your deposit. Once deposit is placed, we have to reserve it from rental stock and will charge a cancellation fee regardless of whether or not you are able to use the equipment.

RENTERS WITH INSURANCE: McNulty Nielsen requires General liability Insurance of 1,000,000 and Rented Equipment Insurance listing the coverage amount and the deductible. Most Rented Equipment Insurance has a deductible for damaged equipment of \$1,500 to \$3,500 ...this means that loss or damages of equipment up to your deductible will be charged to the credit card on file. Before you place an order please be aware of the terms of your insurance carrier. **If no insurance is received before the equipment is picked up a 30% increase in price will be charged to the credit card on file.**

RENTERS WITHOUT INSURANCE: McNulty Nielsen will rent with no insurance on most orders with an equipment value of less than \$20,000. The increase in rental rate for orders with no insurance is 30% of the rental amount.
